

J-BMP Terms of Service

The J-BMP Terms of Use (hereinafter referred to as the "Terms") apply to all users of J-BMP (hereinafter referred to as the "Users"). J-BMP (hereinafter referred to as "The Website") is provided by Think Nature Inc (hereinafter referred to as "The Company").

Article 1.(Use of the Website)

- i. The website is a web application that utilizes and analyses The Company's biodiversity big data and provides a visualization of not only the distribution of living organisms, but also ecosystem services such as carbon sequestration, conservation priorities, and nature-related risks such as climate change on a map.
- ii. The Company and its officers and employees shall not be liable for any loss or damage to life, body, or property arising out of or in connection with any reliance placed on any data, information, text, images, programs, etc. (hereinafter referred to as "Content") on The Website or any activity carried out in reliance on the Content.

Article 2 (Copyright).

- i. Copyright and all other intellectual property rights relating to Content on The Website belong to The Company in principle, except where they are owned by a third party.
- ii. The User may not reproduce, publicly transmit, publish, distribute, translate, adapt, broadcast, or sell any of The Company's Content on The Website beyond the scope of private use as defined by copyright law without obtaining our prior permission.
- iii. Users must not use the content of the Website for commercial purposes without obtaining our prior permission.
- iv. Users may not download large quantities of Content from The Website, collect data from the Content, disassemble, decompile, reverse engineer or otherwise analyze the source code, structure, ideas, etc. of the Website.
- v. If you cite Content from The Website, you must indicate the source in the manner illustrated below. However, you must not modify, summarize or transpose The Company's Content without The Company's permission in advance.

- i. The personal information of Users obtained on The Website shall be handled properly in accordance with the privacy policy stated on The Company's website.

Article 5 (Applicable law).

- i. These Terms shall be governed by and construed in accordance with the laws of Japan.
- ii. The Naha District Court shall be the exclusive agreement jurisdictional court of first instance for any disputes arising between the User and The Company in relation to these Terms.
